ORDER

Before the court is the above styled and numbered cause of action. On December 3, 2013, this court appointed Receiver Thomas Taylor as receiver over the assets of Defendants Robert A. Helms, Janniece S. Kaelin, Deven Sellers, Roland Barrera, and Defendant entities Vendetta Royalty Partners, Ltd., Vendetta Royalty Management, LLC, Vesta Royalty Partners, LP, Vesta Royalty

Management, LLC, Iron Rock Royalty Partners, LP, Iron Rock Royalty Management, LLC, Arcady Resources, LLC, Barefoot Minerals, G.P., G3 Minerals, LLC, Haley Oil Company, Inc., Lake Rock, LLC, SeBud Minerals, LLC, and Technicolor Minerals, G.P. (collectively, the “Receivership Defendants”) (Clerk’s Doc. No. 11).

On September 23, 2014, Plaintiff United States Securities and Exchange Commission, through counsel; Defendant Robert Helms; Defendant Janniece S.Kaelin; Defendant Deven Sellers; Defendant Roland Barrera; Receiver Thomas Taylor, for the Receivership Entity Defendants; and Relief Defendant William Barlow, individually and on behalf of Global Capital Ventures, LLC, each filed with the court a Notice, Consent, and Reference of a Civil Action to a Magistrate Judge (Clerk’s Doc. No. 115). All parties thereby consented to a magistrate judge’s consideration of all dispositive motions and trial in this cause.

IT IS THEREFORE ORDERED that the above styled and numbered cause is **REFERRED** and **REASSIGNED** to United States Magistrate Judge Mark Lane to conduct all proceedings and order the entry of judgment in accordance with Section 636(c) of Title 28 of the United States Code and Federal Rule of Civil Procedure 73.
